During the program, students will participate in several hands-on lessons taught by Sheboygan Police Officers, including police operations, traffic stops, defense and arrest tactics, handcuffing, scenario resolutions, crime scene investigations (evidence collection, fingerprinting, crime scene reconstruction) and more! Students will also hear presentations from representatives of specialized units such as the Drug Unit, K9, and SWAT and more!

The five-day program is currently scheduled to run the week of Monday, July 16th through Friday, July 20th from 8:30 AM-12:30 PM, at the Sheboygan Police Department.

Cadets will receive a JPA t-shirt and a Cadet Handbook. Successful graduates will be able to attend a graduation ceremony where they will receive their JPA Graduation Certificate. Our expectation is that graduates of the program will someday become the community leaders of tomorrow - instilled with an appreciation and respect for law enforcers and their role in society. The goal of the program is simple - to build meaningful partnerships with students, motivating them to be responsible, involved citizens.

Due to the continued interest in this program we have added some criteria when reviewing applications. One of those being SASD students will be given priority over non-SASD students. Class size is limited, so if you would like your child to be considered for the Academy, please complete the information below as soon as possible. Return printed forms to school or the Sheboygan Police Department **by June 6th**. Students selected for the Academy will be **notified via email** prior to June 20th and will receive additional information at that time. Why do you want to join the Junior Police Academy (**required**)?

The Junior Police Academy is an intensive week-long program designed to provide cadets a unique experience. It gives them the opportunity to see and understand how and why police officers do what they do.

Cadets are representatives of themselves, their families, their communities, and the academy itself. They will be held to high moral and ethical standards. Cadets are required to abide by all rules of the program and adhere to all local, state, and federal laws and ordinances.

Safety is the number one priority! Failure to follow academy rules or instructor directions may result in immediate removal from the program.

Cadets will be operating in a live, working police department under close supervision from their instructors (at no time will cadets have access to live or lethal equipment).

Because of ongoing and active investigations at the SPD, backgrounds will be completed on all applicants. Severe safety violations will result in immediate removal and possible legal consequences. We want you to have fun and learn but also feel safe while doing so!
